Dear Chief Zimmerman,

University scientists, and even the National Research Council as late as February 2015, discuss geoengineering as if it were some possible action that might be taken in the future. In the March 20, 2015 issue of Science Magazine, the Editor described a "hypothetical" geoengineering circumstance in the future that might be necessary. I responded with a truthful rendition of reality (Exhibit A).

As you know, forensic scientists measure chemical traces to determine the origin of explosives and narcotics. By a similar approach, I discovered that post-spraying rainwater has the same chemical signature as water exposed to coal fly ash. When coal burns it produces heavy ash that settles and ultra-fine toxic "fly ash" that must be trapped and stored away from the environment. Now, day after day, month after month, coal fly ash is being deliberately sprayed over San Diego and over people throughout America. So, what happens when you breathe air polluted with this stuff? As a human female, I submit, you should protect the young. Felony child endangerment certainly falls within your sworn responsibility.

If a foreign adversary began spraying in similar fashion, those tanker-jets would be forced or shot down without delay. If an individual were doing same, you would order that to stop, even if it meant the use of deadly force. What is different here? You should use every judicial and legislative avenue available to halt the on-going aerial spraying that is taking place without public knowledge and without informed consent, halt the assault on humanity. Otherwise, when awareness strikes and citizens realize that their city officials are doing nothing, there undoubtedly will be riots in the streets. Then, through martial law, the monsters can steal, not only people's health, but their freedom as well. Is it possible that this might be the underlying motive? Create an intolerable situation with no help from officialdom so as to induce people to riot in selfdefense and thus justify imposition of martial law? Think about it. Of course, city officials can and should defuse such a scheme, whether real or not.

Without delay, a press conference could be called to announce that San Diego has filed to the U. S. Supreme Court requesting an emergency stay order on the spraying and announce other appropriate orders for the government to show cause and risks of spraying. To help with the phraseology, please refer to <u>Exhibit</u> <u>B</u>, an act before the State of Rhode Island about geoengineering. Perhaps in this way you can obviate people rioting in self-defense against monstrous atrocities. Please help those whom you serve.
