### Waking Up to Climate Policy Confusion and Devastation

As far back as the 1990s, citizens have been besieged with "news" of the pending environmental catastrophe resulting from anthropogenic (human-caused) global warming blamed on fuel-burning production of carbon dioxide. Al Gore's widely-viewed 2006 documentary movie, "An Inconvenient Truth", painted frightening pictures of the disasters that would befall our natural environment. The mass media throughout the world glommed onto the global-warming fear.

The United Nations for decades has been at the forefront of promoting global warming, supporting and enlisting opinions of hundreds of climate scientists, and producing legally binding international treaties supposedly to halt or at least place limits on global warming. Most recently in 2015, the 21<sup>st</sup> Conference of the Parties to the United Nations Framework Convention on Climate Change took place in Paris, France. Referred to as COP21, the Paris Agreement was adopted by 196 Parties and entered into force on November 4, 2016. The main goals of COP21 are to force signatory nations to reduce greenhouse emissions and to commit to financial contributions.

Upon taking the oath of office on January 20, 2025, U.S. President Donald J. Trump announced his intention to withdraw from the Paris Agreement. To many around the world, especially in Europe, President Trump's intention to withdraw from COP21 caused much confusion and concern for the well-being of planet Earth. My purpose in writing this article is to dispel confusion and concern by bringing to light the United Nations' wrongdoings in connection with global warming and environmental warfare.

The underlying idea of COP21 is that atmospheric carbon dioxide traps Earth's heat, prevents its escape into space, and causes global warming. That is the majority view of government funded climate scientists; the minority view, usually proffered by oil-industry funded scientists, is that there is no global warming, only natural variations. As I describe in the following, neither the majority nor minority viewpoints are correct. Global warming is occurring, but it is caused primarily by particulate pollution, natural, industrial, and deliberate.

Throughout the climate science community there has been misinformation and disinformation. For example, the Climate Research Unit at the University of East Anglia in the United Kingdom was at the forefront of global-warming climate models. Then, beginning on November 19, 2009, a whistle-blower leaked thousands of emails and documents from the Climate Research Unit that appeared to validate earlier allegations of science suppression, misrepresentation, and data-altering.

In response to the scandal, called "Climategate", almost everywhere the phrase "global warming" was replaced with "climate change". With a new name, the global warming agenda nevertheless continued and was extended to include ideas of "geoengineering" the entire Earth to compensate for supposed human-caused global warming, and also to include specific high-tech weather modification activities.

About Climategate, as quoted in a November 24, 2009 Wall Street Journal article: Yet even a partial review of the emails is highly illuminating. In them, scientists appear to urge each other to present a "unified" view on the theory of man-made climate change while discussing the importance of the "common cause"; to advise each other on how to smooth over data so as not to compromise the favored hypothesis; to discuss ways to keep opposing views out of leading journals; and to give tips on how to "hide the decline" of temperature in certain inconvenient data.... When deleting, doctoring or withholding information didn't work, Mr. Jones suggested an alternative in an August 2008 email to Gavin Schmidt of NASA's Goddard Institute for Space Studies, copied to Mr. Mann. "The FOI [Freedom of Information] line we're all using is this," he wrote. "IPCC [Intergovernmental Panel on Climate Change] is exempt from any countries FOI—the skeptics have been told this. Even though we . . . possibly hold relevant info the IPCC is not part of our remit (mission statement, aims etc.) therefore we don't have an obligation to pass it on"....we do now have hundreds of emails that give every appearance of testifying to concerted and coordinated efforts by leading climatologists to fit the data to their conclusions while attempting to silence and discredit their critics.

How is an ordinary person, not a trained scientist, to make a judgment on the legitimacy of global warming, especially in light of science suppression, misrepresentation, and data-altering?

In science there should be truthful debate, discussion, and controversy. An open airing of diverse ideas and interpretations generally leads to better understanding, and to the forward progress of science. Real science is all about truth. Agenda-driven scientists, on the other hand, identify themselves by their willingness, individually or with others, to lie, deceive, and besmirch their opposition and to engage in science suppression, misrepresentation, distorting and/or falsifying data.

My approach is entirely different: I begin at the foundations of knowledge, and seek to understand the commonalities. Then I proceed to discover the underlying mistakes that have been made.

In 1957, Roger Revelle and Hans E. Suess published a scientific article, entitled "Carbon dioxide exchange between atmosphere and ocean and the question of an increase of atmospheric CO<sub>2</sub> during the past decades." In that article Revelle and Suess suggest that the Earth's oceans would absorb excess carbon dioxide generated by humanity at a much slower rate than previously predicted by geoscientists and might create a "greenhouse" effect that might eventually lead to global warming.

Twenty years after publication of the Revelle-Suess article, over a period of four years, I had lengthy discussions with Suess about the possibility of global warming and the necessity to validate the effect of increased atmospheric carbon dioxide in a broader framework that includes the potential variability of Earth's major heat source, the Sun, the factors potentially affecting the variability of Earth's reflectivity and its consequences, the potential variability of heat being brought to the surface from deep within the Earth and its potential impact on ocean warming and on changes in ocean circulation.

Clearly, there was no certainty that global warming would be an inevitable consequence. Nevertheless, the United Nations made that assumption without considering scientific evidence to the contrary. In legitimate, ethical science all possible contributing factors must be considered. The failure of climate scientists, especially those funded by the United Nations, to ever mention "chemtrails" in their reports calls into question, not only the ethics of their work, but the legitimacy of the United Nations climate science programs.

Chemtrails is a term frequently used to describe the long, white particle trails emplaced in the atmosphere by jet aircraft which disperse first into cirrus-like clouds then become a white haze in the sky (Figure 1). Not only are chemtrails selectively ignored by academic scientists, when queried, numerous national governments, assert that they are "contrails" consisting of harmless ice crystals. Ask yourself: What is wrong with this picture? Why would governments lie? Why would United Nations climate scientists lie (by omission)?

In an effort to understand what was being jet-sprayed into the air we breathe, concerned citizens took post-spraying rainwater samples, and had them analyzed by commercial laboratories. Usually only aluminum analyses were requested, sometimes aluminum and barium, and occasionally aluminum, barium, and strontium. To me these laboratory results indicated that the jet-emplace substance was capable of being partially dissolved by atmospheric water. The scale involved suggested a readily available, low-cost substance. The possibility came to mind that coal fly ash, a toxic waste product of industrial coal burning, might be involved.

By comparing laboratory-measured ratios of aluminum to barium and strontium to barium from concerns citizens' rainwater analyses to corresponding coal fly ash laboratory ratios reported by Spanish scientists, I discovered the first evidence that the substance being jet-sprayed into the air we breathe is coal fly ash. Coal fly ash contains numerous toxins including arsenic, chromium, mercury and others. In 2015, my scientific article on this investigation was published in *Current Science*, a journal of the Indian Academy of Sciences.

Immediately after publication, the editor received a letter from an individual demanding retraction of my article based upon his long list of lies. That article, the first in the scientific literature concerning jet-emplaced particle trails, was not retracted. My next two articles, peer-reviewed and published in public health journals, however, were retracted without me seeing or having the opportunity to respond to assertions by that disinformation agent and several of his colleagues. These were reprehensible actions, totally contrary to the standard practice of allowing the author self-defense.

The best, although non-scientific, evidence of my correctness was the veracity by which disinformation agents (CIA?) acted to suppress knowledge of the public health threats of chemtrails. Subsequent extended laboratory analyses of rainwater, snow, and other trapped material further verified my initial findings that most chemtrails consist of particles deemed too toxic to be allowed to exit smokestacks of coal-burning industrial furnaces.

Air pollution, the world's leading cause of environmental human fatalities, is a major contributor to noncommunicable disease. Aerosolized coal fly ash, a particularly hazardous form of air pollution, pours forth from numerous smokestacks in India and China. However, citizens of the United States, the British Commonwealth, and the European Union live in a fools' paradise. They have been led to believe that coal-burning utilities in their countries trap this very toxic substance so it does not exit smokestacks and directly pollute the air. They do store the exhaust precipitates as solid waste, but then the utilities surreptitiously supply the coal fly ash to be covertly jet-sprayed into the very air people breathe, and indeed profit from that diabolical activity.




Figure 2. Periodic table with red dots showing elements documented to exist in coal fly ash. Radioactive decay products, such as radium, are not indicated.

Coal fly ash has thus become a toxic environmental nightmare consisting mainly of tiny spherical particles. These particles contain concentrations of the most hazardous chemical elements in coal, each of which can harm the natural environment in numerous ways (Figure 2).

Aerosolized coal fly ash contaminates the environment with mercury, one of the most toxic poisons known, and known to move up the food chain. Aerosolized coal fly ash, lofted into the upper atmosphere (stratosphere), destroys Earth's ozone layer, and exposes all surface life to the deadly ultraviolet radiation from the sun. Contaminating the environment with the massive quantities of iron contained in coal fly ash upsets the delicate iron balance in nature and in the bodies of exposed biota. Aerosolized coal fly ash has a plethora of adverse human and environmental health consequences.

Pause for a moment and consider the following question: Would President Trump's intention to withdraw from COP21 stop the chemtrail poisoning the air we breathe and harming almost all of natural life? The answer is no. All President Trump's intention would do is to halt actions to reduce greenhouse gas emissions and provide financial contributions.

To my knowledge, President Trump has not yet had the opportunity to understand the whole diabolical, covert rationale behind chemtrails. Presumably in time he will.

On February 14, 2025 my formal "whistle-blower" complaint was received at the office of the Inspector General of the U.S. Department of State. **Allegation:** The U.S. Secretary of State and officials of the U.S. Department of State have been duped and deceived by the Deep State and by the United Nations, through a highly deceptive United Nations International Treaty, which covertly serves as a portal to facilitate crimes against American citizens and the environment. These activities presumably are, and have been, co-opting many billions of taxpayer provided funds to support the waging of undisclosed environmental warfare against American citizens.

**Overview:** All United Nations International Treaties are the purview of the U.S. Department of State. Generally, the title of a treaty accurately describes its intent. There is, however, one blatant exception, a specific United Nations International Treaty that is in fact a Trojan horse, called the *Convention on the Prohibition of Military or Other Hostile Use of Environmental Modification Techniques*. The title is deceptive: Said *Convention does not* prohibit use of hostile environmental modification techniques. What it does instead, is to deceitfully mandate signatory "State Parties" to participate in unspecified, undisclosed, and limitless "peaceful environmental modification" which is in itself a false statement as any large-scale or global environmental modification is profoundly harmful.

Scientific evidence indicates that the current and prior U.S. Secretaries of State were clearly duped and deceived into believing that the sole purported purpose of said *Convention* is simply to melt Arctic ice, when in fact the undisclosed purpose and consequence is to conduct hostile environmental warfare on Americans and other citizenry.

Said hostile environmental warfare includes, but is not limited to:

- Poisoning the air people breathe with toxic coal fly ash jet-sprayed into the air and/or added to commercial jet fuel for the same purpose.
- Deceiving populations, presumably by CIA operatives, as to the adverse health consequences of deliberately poisoning the atmosphere with aerosol particles including, but not limited to, coal fly ash.
- Adverse health risks of aerosolized coal fly ash include, but are not limited to, pulmonary, neurodegenerative, and cardiovascular diseases.
- Wholesale destruction of life by said toxic coal fly ash, includes but is not limited to, insects, birds, bats, beneficial aqueous phytoplankton, agriculture, plants and trees.
- Altering natural weather patterns upon which agriculture is based. One example: For
  more than a decade, the coast of California has been assaulted with jet-sprayed coal fly
  ash, which blocks the in-flow of moist air from the Pacific Ocean thereby causing
  drought and desiccation. When rain in the next few days was predicted, jet-spraying
  activities increased, further causing drought and desiccation, enabling forest fires and

- forcing farmers out of business so that wealthy elites like Bill Gates can buy up the farmland at bargain prices.
- Coal fly ash jet-sprayed into the air and added to commercial jet fuel makes atmospheric
  water more electrically conducting enabling covert Deep State operatives to exert
  control over weather patterns, including hurricanes, for political and/or commercial
  benefit.

One especially deadly consequence is that aerosolized coal fly ash kills stratospheric ozone which shields Earth from the deadly ultraviolet component of sunlight. The United Nations Montreal Protocol misdiagnosed the problem. It is not refrigerant gases, but aerosolized coal fly ash that is the principal cause of stratospheric ozone depletion.

Emplacing aerosol particles, undertaken under aegis of said United Nations *Convention*, causes global warming. At the same time the United Nations deceives the public by falsely asserting that carbon dioxide is the principal cause of global warming. This is the greatest scientific fraud ever perpetrated.

**Evidence:** The enclosed published document, *Open Letter to the International Criminal Court Alleging United Nations Complicity in Planetary Treason*, provides specificity of the above allegations with scientific references.

**Remediation Sought:** First and foremost the Secretary of State should be made aware of the allegations and evidence in this document and should act to halt any and all further activities undertaken under aegis of said *Convention*.

The Secretary of State may wish to bring this matter to the attention of President Trump including requesting Elon Musk's DOGE team to investigate the nature and extent of government corruption and theft of funds. A plethora of agencies may be involved including, but not limited to, the CIA, U.S. Air Force and other DOD entities, the EPA, and others.

All aircraft activities that add particulate matter to the atmosphere should be prohibited, including activities that add coal fly ash or other particulate-forming substances to jet fuel. Foreign aircraft should likewise be prevented from similarly poisoning the atmosphere if they are to utilize American airspace.

The network of Deep State government employees and contractors engaged in covert atmosphere modification, manipulation, and pollution needs to be revealed and terminated.

The United Nations Intergovernmental Panel on Climate Change [IPCC] was established in 1988 by the World Meteorological Organization and the United Nations Environment Programme. Its job is to advance knowledge of climate change supposedly caused by human activities. But as noted above, the IPCC never to my knowledge addressed the climate change consequences of chemtrails, jet-sprayed particles.

One well-known consequence of aerosolized particles pertains to their effect on rainfall. As published by NASA in 2010: "Normal rainfall droplet creation involves water vapor condensing on particles in clouds. The droplets eventually coalesce together to form drops large enough to fall to Earth. However, as more and more pollution particles (aerosols) enter a rain cloud, the same amount of water becomes spread out. These smaller water droplets float with the air and are prevented from coalescing and growing large enough for a raindrop. Thus, the cloud yields less rainfall ...." Eventually, however, the cloud may become over-saturated and release its moisture in torrents, not necessarily in the same location.

Retired U.S. Air Force Brig. Gen. Charles Jones reportedly made the following statement: "When people look up into the blue and see white trails paralleling and crisscrossing high in the sky little do they know that they are not seeing aircraft engine contrails, but instead they are witnessing a manmade climate engineering crisis facing all air breathing humans and animals on planet Earth.... Toxic atmospheric aerosols [are] used to alter weather patterns, creating droughts in some regions, deluges and floods in other locations ...."

There is another major consequence of natural, industrial, and deliberate aerosol pollution that academic climate scientists failed to understand.

Academic climate scientists consider global warming as a radiation imbalance. Heat Earth receives from the sun, instead of being fully returned to space, is partially trapped allegedly by carbon dioxide in the atmosphere which supposedly causes global warming. That is the much-promoted story-line promulgated by the United Nations Intergovernmental Panel on Climate Change [IPCC].

But there is a different explanation for global warming that was unexpected by academic climate scientists. Particles in the lower atmosphere (troposphere) are heated by solar radiation and by radiant heat from the Earth, and transfer that heat to atmospheric gases by molecular collisions. The resultant heating increases atmospheric temperature, and reduces the temperature difference relative to air near the surface, which reduces atmospheric convection [up-down air circulation], and concomitantly reduces convective heat transport from the surface. As I published in the peer-reviewed scientific literature, this is the mechanism whereby chemtrails, jet-emplaced particulate matter, cause global warming.

On or about February 14, 2016, an oily-ashy substance fell on seven residences and vehicles in Harrison Township, Michigan (USA). Suspecting this was an accidental release from an aircraft engaged in covert geoengineering, I obtained samples from one of the residents for analysis and advised the Michigan Department of Environmental Quality on what analyses should be conducted. The air-drop material consists of a mixture of particles in dark clumps that resemble plant material, including leaves, seeds and fruit skins, mixed with coal fly ash and salt.




Figure 3. Upper Left: Air-Drop Distribution; Upper Right: Cryoconite-hole Distribution in Glacier; Lower Left: Air-Drop Artificial Cryoconite; Lower Right: Natural Cryoconite.

Figure 3 shows patterns of quasi-circular holes (referred to as 'cryoconite holes') that are observed worldwide on ablating glacier surfaces, and which resemble the distribution pattern of the Michigan air-drop material. Because of its dark color, natural cryoconite — windblown dust made up of rock particles, soot, and microbes — absorbs sunlight and melts its way into glacier ice. The resemblance between cryoconite and the air-drop material is a clear indication that the air-drop material is artificial cryoconite whose purpose is to melt glacial ice and to enhance global warming.

The global-warming consequence of coal fly ash chemtrails together with the data from the accidental air-drop of artificial cryoconite is clear indication that the covert "peaceful environmental activity" mandated by the Trojan horse United Nations International Treaty is to

melt arctic ice to create a northern passage for ships and a means to access mineral resources beneath the ice. But that is only a subterfuge: In reality it is a "foot-in-the-door" to conduct environmental warfare against human populations and their governments, to ruin human and environmental health, and to disrupt their ability to produce food.

In the following I provide a few specific, but non-exclusive, examples.




Figure 4. NASA Worldview of the California coast on December 11, 2017.

Our planet rotates and some of its rotational energy is transferred to the atmosphere; that is the primary mover of weather masses. Additionally, weather masses move, driven by differences in pressure, from high pressure to low pressure regions; not the reverse. The near-daily, year-after-year aerial particulate spraying along the California coast and off-shore in the Eastern Pacific Ocean heats the atmosphere. The nearly continuously heated atmosphere results in nearly continuously elevated atmospheric pressures. That artificially-created high-pressure zone along California's coast acts like a wall to prevent the flow of Pacific Ocean moisture-laden weather masses from coming ashore (Figure 4). The consequence is a persistent artificial drought for California. Sometimes after a weather forecast predicting rain in a few days, I have observed that the spray-jets intensify their spraying thus often preventing the predicted rainfall.

In 2018, Mark Whiteside and I published a scientific article showing that the jet-sprayed aerosols increase the risk of wildfires specifically in California, but generally elsewhere. The great Los Angeles, California (USA) wildfires that started in January 2025 are symptomatic of the consequences of covert environmental warfare.

The following shows some of the human health problems caused by toxic chemical elements in coal fly ash.

# Aluminum (AI)

• (chemically mobile form) implicated in neurological disorders

# Antimony (Sb)

• lung disease, irritation of eye and skin, stomach pain, ulcers

# Arsenic (As)

lung cancer, skin cancer, nervous system damage, urinary track cancer

# Barium (Ba)

• cardio abnormalities, kypokalemia, muscle weakness and paralysis

#### Beryllium (Be)

permanent scarring of lungs, lung cancer, heart failure

### Boron (B)

damage to testes, intestines, liver, kidneys and brain

### Cadmium (Cd)

• lung cancer, emphysema, kidney disease, hypertension

# Chromium (Cr)

• lung cancer, asthma, wheezing, anemia, stomach cancer, ulcers in stomach and intestines

### Lead (Pb)

• brain swelling, nervous system and cardiovascular problems, kidney disease

### Manganese (Mn)

• irritability, aggressiveness, neurological disorder including tremors, difficulty walking and facial spasms

## Mercury (Hg)

• nervous system damage, fetus developmental defects, mental retardation

#### Nickel (Ni)

headaches, lung fibrosis, lung cancer, nasal cancer, epigenetic effects

#### Selenium (Se)

• neurological problems including impaired vision and paralysis

### Thallium (TI)

nervous system damage, problems of lung, heart, liver and kidney

Particulate pollution, and especially aerosolized coal fly ash, is extremely harmful to human and environmental health. Combustion-derived spherical magnetite pollution nano-particulates, similar to those found in coal fly ash, have been found in the brains of persons with dementia.

Covertly disrupting natural weather can lead to crop failures, livestock decimation, and starvation; all of which can destabilize political regimes and exacerbate potential hostilities. Indeed, former Iranian President Mahmoud Ahmadinejad accused Western nations of surreptitiously causing droughts in his country.




Figure 5. NASA Worldview satellite image from February 4, 2016 showing jet-laid trails blanketing the air above the Republic of Cyprus but nearly absent in surrounding regions.

Figure 5 shows particulate trails blanketing the Republic of Cyprus whose citizens, so far unsuccessfully, sought an explanation from their government for the deliberate obscuration of their skies.
